### **CCG Assurance**

#### **Lead: Tim Goodson, Chief Officer**

- 2.3 NHS England published the overall rating for each of the 209 CCGs as part of their annual assessment under the CCG Improvement and Assessment Framework (CCG IAF) on 21 July 2017. I am pleased to announce that NHS Dorset Clinical Commissioning Group has received an overall headline assessment of 'Good', which we have maintained from 2015/16.
- 2.4 The Better Care clinical priority ratings have improved, with Cancer assessed as 'Outstanding' and Dementia as 'Good'. Mental Health 'requires Improvement' which we can focus on for 2017/18.
- 2.5 The full results are available on [My NHS](#) and include the overall scores, as well as three of the clinical priority areas which focus on cancer, mental health and dementia.
- 2.6 Looking forward, NHS England is working to divide the South Region into two to ensure provision of the necessary leadership, continuity and capacity to

support staff and the wider NHS across the South. It is aligning the leadership of existing teams to the two regional directors, which means Dorset will be aligned to the South West region (Regional Director, Jennifer Howells). Regional functions will continue to operate across the South West and the South East. NHS England is working to ensure these revised portfolio arrangements are in place by September.

## **GP Patient Satisfaction Survey results**

- 2.7 The latest patient survey has recently been published. Dorset practices as a whole are performing well and as a CCG, averages are above the national average.
