2.3 360 Stakeholder survey has been brought forward due to the election and the survey will run from 9 March – 3 April 2015. We have identified our list of stakeholders and submitted these to IPSOS Mori on 27 February 2015. Results will be collated and reports due on 8 May 2015 in time for our Quarter 4 Assurance meeting on 25 June 2015.

2.4 Quarter 3 Assurance meeting will be held on 9 April 2015, work is currently underway to prepare for this meeting.

Vanguard Application

2.5 We submitted the Vanguard application on behalf of the Health Community in Dorset on Friday 6 February. Our application was focussed on our Clinical Services Review and our aim to transform the system to ensure future clinical and financial sustainability. Over 250 applications have been received nationally and successful applicants will be notified by end February 2015.

General Election, Local Election

- 2.6 The 2015 General Election will take place on 7 May 2015. Between now and then we can reasonably expect the NHS to be under greater scrutiny than usual. It has been confirmed that Parliament will be dissolved on 30 March 2015 and this is when the restricted pre-election period (sometimes referred to as "Purdah") will begin. The date is likely to be earlier in Dorset due to the local elections in Poole and Bournemouth a few days before the national period.
- 2.7 Once the Election is formally called, Cabinet Office will issue pre-election guidance to all Government Departments and their arm's length bodies. Many of the principles in it will be relevant to NHS bodies, as we spend public money and make public announcements.
- 2.8 It is important that everyone is aware of the general principles that would apply in a pre-election period:-
 - the NHS should remain politically impartial at all times staff should not be asked to engage in activities which are likely to call into question the political impartiality of their organisation, or which could give rise to criticism that public resources are being used for party political purposes; and
 - NHS business should proceed as normal with no disruption to patient services – but as issues relating to the NHS tend to be high profile, and likely to attract far greater scrutiny in the pre-election period than would otherwise be the case, special care will be needed to avoid being caught up in issues of propriety or party political controversy.
- 2.9 With this in mind, the way that activities are handled before and during the pre-election period may need to change. For example, further consideration may need to be given to any new decisions, announcements or consultations whether issued online, via bulletins, through the media or stakeholders events or exhibitions, printed materials, speaking engagements, stakeholder engagement and requests for information.
- 2.10 In order to plan appropriately for the pre-election period and until formal General Election Guidance for 2015 is issued, colleagues across the health and care system are advised to review the <u>existing Cabinet Office pre-election</u> guidance from 2010.

2.11 Once the Cabinet Office issue guidance for 2015, further links will be provided. The published General Election timetable <u>can be found here</u>. In the meantime, for all other election related queries, please contact the <u>communications</u> team.
