1. Introduction

- 1.1 This report provides the latest version of the Governing Body Assurance Framework (Appendix 1). This framework provides assurances against the key strategic risks and controls that the Governing Body must consider when seeking internal assurance.
- 1.2 The Directors' Performance meeting has operational responsibility for maintaining the Governing Body Assurance Framework with support from the Patient Safety and Risk team.
- 1.3 The framework has been linked to the strategic objectives of the organisation and also serves as a source of external assurance for the NHS England – South (Wessex) quarterly assurance processes.
- 1.4 Where there is direct correlation, links are made to risks on the Corporate Risk Register. The Corporate Risk Register will continue to be uploaded to the Board Portal on a monthly basis for members to access.
- 1.5 The controls for each of the strategic risks are ordered (top to bottom) in terms of the level of assurance the control provides. The most important assurance (e.g. NHS England assurance checkpoint) would be at the top, with lower level internal assurances at the bottom.
- 1.6 Following requests from the Audit and Quality Committee, a review of the GBAF format is to be undertaken to ensure the document is fit for purpose.

2. Gaps in Controls and Assurances

- 2.1 This section of the report summarises the actions that are planned to rectify areas where gaps have been identified in controls or assurances (these appear in blue in the main document). These have been summarised in the table below:
