1. Introduction

- 1.1 The purpose of this report is to outline the continued progress of the Two Year Delivery Plan priorities for 2014/16. The priorities have been identified by each Clinical Commissioning Programme and will be implemented within the two year period.

2. Report

- 2.1 Each of the 6 Clinical Commissioning Programmes (CCP) has a prioritised work plan and investment plan for 2014/16. These include key outcomes to be delivered which are linked to the national operating/outcomes frameworks and other locally prioritised projects. Some of these priorities may also fall into one or more of the three major reviews that the CCG is also currently undertaking, i.e., the Clinical Services Review, the Better Together Programme and the Urgent Care Review.
- 2.2 The Annual Delivery Plan 2013/14 has been completed and the final position was presented to the Governing Body meeting on 16th July 2014. This report listed the end of year position of all projects and any projects not completed have been included in the 2014/16 priorities.
- 2.3 Programme Leads have been asked to update the 2014/16 Two Year Delivery Plan monitoring template summary with the position as at August 2014 this is attached as Appendix 1.

- 2.4 Programme leads have given indications of where progress of the priority is in relation to the commissioning cycle. For example, two reds and one orange would equate to the priority being in the 'Current Service Review' stage 3.
- 2.5 At the end of September 2014 seventeen priorities have already reached completion (by completion means that they have reached the contract and mobilisation stage – double blue stage) and one has not yet commenced. It should be remembered that this is a two year plan and these priorities will be monitored over this period.
- 2.6 Three priorities are reporting that they are not currently on plan:
- **Cardiovascular Disease, Stroke, Renal and Diabetes CCP**
 - 3.1.3 Podiatry Access
 - 3.3.1 Nursing Care to support Frail Elderly with heart failure at End of Life and avoid hospital admission.
 - **Mental Health & Learning Disabilities CCP**
 - 5.2 Map the mental health system and development of an up-to-date programme budget.

3. Conclusion

- 3.1 Members are asked to note the progress being made against the NHS Dorset CCG Two Year Delivery Plan 2014/16.
